6. CATEGORIES AND CLASSES

Pre '65 White

• Motorcycles before 1965

Gentleman White

- Classic motorcycles before 1978 (Pre '78)
- Classic motorcycles with 2 dampers with air cooling system and drum brakes Clubman Yellow
- Classic motorcycles before 1978 (Pre '78)
- Classic motorcycles with 2 dampers with air cooling system and drum brakes Expert Green
- Classic motorcycles before 1978 (Pre '78)
- Classic motorcycles with 2 dampers with air cooling system and drum brakes

All motorcycles of Pre '65, Gentleman, Clubman and Expert categories must respect the following executive restrictions: air cooling system, classic rear suspension with 2 absorbers, drum brakes.

Maximum number of riders allowed is following: 200.

To participate in the European Trial Vintage CUP a rider must hold a regular driving licence and a National licence of his Federation and starting permission. Motorcycles and their equipment must comply with the National legal requirements for Road Traffic of the country in which the vehicle is registered.

A rider, accepted for the meeting, who cannot take part, must, in writing or by fax, inform the organizer as soon as possible, stating an acceptable and valid reason.

9. STARTING NUMBERS

Each rider will receiv one sticker with a starting numbers and colour of track, and must be <u>clearly</u> visible.

10 .ADMINISTRATIVE & TECHNICAL INSPECTION

The administration and technical verification will take place in Folgaria (TN), Palasport (admin) and Piazza G. Marconi (technical).

11. STARTING PROCEDURE

First rider will start on Saturday 6th Sept. at 12.00 Sunday 7th Sept. at 9.00

12. PRIZES

The riders placed on the first 3 places each classe receive cups.

13. PRIZE-GIVING CEREMONY

Sunday 7th September at Palasport or Piazza G: Marconi – Folgaria. It will be annunced by organizers.

14. PROTESTS

A protest must be in writing, signed and handed over to the Clerk of the Course. The protest fee is 130 euro.

The time limit for protesting against a race or qualification result is 30 minutes after publishing time.
